

Jackson's Kennel Stud Contract

Jackson's Kennel offers stud service to approved bitches only. The requirements are strict and nonnegotiable. Bitches must be:

- Minimum age 2 years old, maximum age 6 years old
- Have full registration with the AKC or an AKC accepted kennel club
- Be Brucellosis negative
- Have a clear fecal within 1 month of breeding
- Be current on vaccinations
- May carry 1 gene of VWD and 1 gene of DCM (either DCM1 or DCM2, but not both)
- Not be affected genetically
- Be of breed standard height, color, disposition
- Be in good health and of a healthy weight
- Not be Z factored (WZ registration)
- Not have any major breed faults
- Have a current normal echocardiography or holter (within 1 yr)
- Have OFA or PennHip hip certification/exam
- Litter estimated COI must be no higher than 39%
- Be of sound temperament and personality
- Display no signs of reactivity or aggression to people or animals
- LH progesterone testing must be performed to confirm ideal mating timing

The dam must be fit, healthy, breed standard, and under control at all times. With stud service you will be provided a copy of the pedigree, copy of the signed contract, links to the stud's health testing, and one profile picture and one stacked picture of the stud.

Conditional Terms: Please be aware pregnancy is not guaranteed. Pregnancy is a complicated process and anything can happen to compromise a pregnancy (from insufficient diet to environmental or accidental exposure). We do offer a conditional next heat stud service re-session if all the following are met (as appropriate per breed);

- I. Progesterone testing was done to track ovulation timing
- II. Mating occurred within 24 hours of peak ovulation
- III. Pregnancy was by veterinarian confirmed to have not taken via a blood relaxin test between 30-35 days from first tie
- IV. Dam was not vaccinated (including Rabies) minimum of 4 weeks prior to start of estrus (heat)
- V. Dam was fed a balanced pregnancy, puppy or all-life stages food (raw voids all re-sessions) – must provide receipts or purchase logs for the last 30 days (i.e. Amazon, eBay, PetSmart purchase history)
- VI. Vet provides a letter stating the dam is healthy, fit for breeding and the pregnancy not taking was not related to inadequate health, poor ovulation, poor hormones or illness, as well as states length of time as an established client exceeds 6 months with at least 2 office visits (or 1 pre-breeding screening or evaluation)

- VII. Dam is between 2-5 years old - any dogs older than 5 are a one-time breeding, we do not promise a second session if pregnancy doesn't take
- VIII. Dam has had a negative Canine Brucellosis result
- IX. Dam is on pregnancy safe medications (vitamins, supplements, flea medication, heartworm medication, dewormer, etc)
- X. Dam was dewormed at least 2 months prior to mating (receipt or purchase print out required if dewormed by the owner or letter/proof from the vet with the date dewormed)

Should the dam fail to meet all the requirements for stud service re-session will be denied. Dams with minimal health testing will not be offered a rebreeding. No exceptions. We require a letter from the vet stating the dam is STD clear (herpes, Brucellosis, ETC) and healthy enough for a re-session. If the next heat mating fails to take as well we will offer one of the following; either ONE more re-session, an AI session (we provide the stud only, we will not pay for the AI collection and service), or one time breeding to a different female who meets our requirements with a statement of infertility by your established vet. No rebreed for miscarriages or reabsorbed litters. A miscarriage is subject to rebreeding at the stud owner's discretion. A litter is considered two live puppies at birth.

¹ Fraud Clause: Jackson's Kennel believes in honesty and openness but we do not tolerate theft or impersonation of us or our dogs. If we find out a litter has been registered without our prior approval we will immediately file a case with the AKC, have the litter registrations revoked, and pursue legal action for theft, defaming, personal identity fraud, and whatever else our lawyer sees fit. We will file a police report and push for charges to be filed. Do not use our registrations, certificates, pictures, kennel name, dog names, or pedigrees as your own. We will not hesitate to act immediately nor will we warn you.

Regarding misrepresentation of testing, your dog, yourself, and any information provided: We do not tolerate being misled. If any information was purposely misrepresented or falsified it will result in immediate termination of this contract and forfeiting of this agreement and stud service.

All payments are final. There are no refunds.
